I, the undersigned, as the owner of said pet's or as the acting agent, do hereby grant Double Dog Dare Ya permission to provide veterinary care for my pet's as they deem necessary. I assume full financial responsibility for any and all costs incurred. I understand that Double Dog Dare Ya will proceed without my consent if they believe it to be important to my pet's welfare.

The person signing this contract is assumed to be the legal owner of said pets or a direct agent of the legal owner. The owner guarantees that the pet is in good health, and is fully vaccinated.

Double Dog Dare Ya shall exercise reasonable care for the pet delivered by the owner for boarding or daycare. It is understood by the owner that this facility is an open cage facility with the dogs interacting on a daily basis. It is understood by the owner that dogs play rough and just as children playing in a school setting we cannot be held liable for any injuries while they are in our care. It is expressly agreed by the owner and Double Dog Dare Ya that DDDY's liability shall in no event exceed the lesser of the current chattel value of the pet of the same species or by the sum of \$500.00 per animal. The owner further agrees to be solely responsible for any and all acts of behavior of said pets.

The owner hereby grants a lien on the pets to Double Dog Dare Ya for all charges resulting from boarding and daycare and any other services rendered. If any such charges shall be unpaid for a period of (15) days after they become due in accordance with this contract, Double Dog Dare Ya may give the owner (10) days notice in writing. The notice may be served by registered or certified mail and be posted to the address of the owner stated within this document. If an animal has not been picked up within (10) days of date stated in notice to the owner, the dog will be assumed abandoned.

If action at law or inequity is necessary to enforce the terms of this agreement, Double Dog Dare Ya shall be entitled to reasonable attorney's fees, costs, and necessary disbursements in addition to any fees which said parties may be entitled.

It is to be further understood that by signing this agreement that all subsequent visits for what ever reason are to be covered in total with the terms stated above.
